## BACKGROUND:

These websites [www.digitalbuildings.co.uk](http://www.digitalbuildings.co.uk), [www.retrogreen.co.uk](http://www.retrogreen.co.uk) (“Our Websites”) use Cookies and similar technologies in order to distinguish you from other users. By using Cookies, We are able to provide you with a better experience and improve Our Websites by better understanding how you use them. Please read this Cookie Policy carefully and ensure that you understand it. Your acceptance of Our Cookie Policy is deemed to occur when you have selected your preferred Cookie options in Our Cookie pop-up and pressed the button.

## 1. Definitions and Interpretation

1.1 In this Cookie Policy, unless the context otherwise requires, the following expressions have the following meanings:

- “Cookie”** means a small file placed on your computer or device by Our Websites when you visit certain parts of Our Websites and/or when you use certain features of Our Website;
- “Cookie Law”** means the relevant parts of the Privacy and Electronic Communications (EC Directive) Regulations 2003 and, where applicable, the UK GDPR;
- “Personal data”** means any and all data that relates to an identifiable person who can be directly or indirectly identified from that data, as defined by the UK GDPR and the Data Protection Act 2018 (the “Data Protection Legislation”); and
- “We/Us/Our”** means Digital Buildings Limited, a limited company registered in England under company number 13605846, whose registered address is Upperwood, Pottery Lane, Inkpen, RG17 9QA and its subsidiary company Retrogreen Limited.

## 2. Information About Us

## 3. How Do Our Websites Use Cookies?

- 3.1 Our Websites may place and access certain first-party Cookies on your

computer or device. First-party Cookies are those controlled directly by us and used only by us. We use Cookies to facilitate and improve your experience within Our Websites and to provide and improve our products and services. We have carefully chosen these Cookies and have taken steps to ensure that your privacy and personal data are protected and respected at all times.

3.2 By using Our Websites, you may also receive certain third-party Cookies on your computer or device. Third-party Cookies are those placed by websites, services, and/or parties other than Us. For more details, please refer to section 4 below.

3.3 All Cookies used by and on Our Websites are used in accordance with current Cookie Law. We may use some or all of the following types of Cookie:

#### 3.3.1 Strictly Necessary Cookies

A Cookie falls into this category if it is essential to the operation of Our Website, supporting functions such as logging in, your shopping basket, and payment transactions.

#### 3.3.2 Analytics Cookies

It is important for Us to understand how you use Our Website, for example, how efficiently you are able to navigate around it, and what features you use. Analytics Cookies enable us to gather this information, helping Us to improve Our Websites and your experience of it.

#### 3.3.3 Functionality Cookies

Functionality Cookies enable Us to provide additional functions to you on Our Websites such as personalisation and remembering your saved preferences. Some Functionality Cookies may also be Strictly Necessary Cookies, but not all necessarily fall into that category.

#### 3.3.4 Targeting Cookies

It is important for Us to know when and how often you visit Our Website, and which parts of it you have used (including which pages you have visited and which links you have visited). As with analytics Cookies, this information helps us to better understand you and, in turn, to make Our Websites and advertising more relevant to your interests.

#### 3.3.5 Third Party Cookies

Third Party Cookies are not placed by Us; instead, they are placed

by third parties that provide services to Us and/or to you. Third Party Cookies may be used by advertising services to serve up tailored advertising to you on Our Website, or by third parties providing analytics services to Us (these Cookies will work in the same way as Analytics Cookies described above). Some Third Party Cookies may also be Strictly Necessary Cookies, but not all necessarily fall into that category.

### 3.3.6 Persistent Cookies

Any of the above types of Cookie may be a Persistent Cookie. Persistent Cookies are those which remain on your computer or device for a predetermined period and are activated each time you visit Our Website.

### 3.3.7 Session Cookies

Any of the above types of Cookie may be a Session Cookie. Session Cookies are temporary and only remain on your computer or device from the point at which you visit Our Websites until you close your browser. Session Cookies are deleted when you close your browser.
